Hereinafter caller "Buyer" under the following terms warranties and conditions. No other warranties or conditions are expressed or implied.

Seller and Buyer agree to enter into this contract under the following binding agreement:

**SELLER WARRANTY**

My Heart Kennels warranties this puppy free from genetic defects that prevent the puppy from being a companion animal only, until the puppy reaches two years of age. If any defect is found, breeder must be notified within forty eight (48) hours of findings. Documentation from a licensed veterinarian must be provided to the Seller. The puppy/dog shall then be returned to the seller upon seller approval in well-cared for condition, with appropriate registration papers at the buyer's expense. Under NO circumstances is this dog to be euthanized without seller's knowledge and/or consent.

Puppy/dog will be up to date on all vaccinations and dewormings when it leaves premise of seller.

We do not guarantee against conditions brought on by stress or environmental changes after the dog leaves our care. Therefore we do no guarantee against hypoglycemia, coccidiosis or parasites. These are common problems in puppies especially under stress of new circumstances, and will not be covered by this warranty although every effort is made to prevent this.

No warranty is expressed or guaranteed as to size, color, disposition or fertility.

**Replacement**

Should a problem covered by warranty arise and be properly documented Seller will then replace the puppy with one of the same sex and hair coat color from the first available litter (puppy to be determined by the seller). (No money will be refunded.)

**Registration**

That the above described animal is a purebred dog, currently registered and re-registerable by buyer with the recording association shown above and that a registration application or individual registration, has been given to Buyer as of the date of purchase.

## Bill of Sale

### **BUYER RESPONSIBILITY**

#### **Veterinarian Examination**

Buyer must take this dog to a licensed veterinarian for a full examination within two business days after date of sale to have the dog examined for health and anatomical make-up.

Failure to do so will result in any and all warranties becoming null and void. Should the veterinarian find a life deformity or a life threatening disease that is not curable he/she must provide a written statement of the deformity or disease.

Should a problem be found the dog must be returned whether dead or alive. Owner must also provide a laboratory report backing the veterinarian's statement and all paperwork including this bill of sale, and registration papers. At no time will My Heart Kennels be responsible for any veterinarian bill incurred by this dog or its owners.

Buyer shall assume full responsibility for the health, anatomical make-up, appearance and temperament of the above described animal once the veterinarian examination is concluded. Buyer is responsible for protecting the puppy/dog from parvo, distemper, or corona virus after two days following the date of sale as these diseases can be contracted after leaving seller premises.

Buyer hereby releases seller and agrees to hold harmless for any liability, injuries or damages to persons or property caused by this puppy/dog.

Buyer must follow **only** the recommended vaccine and deworming schedule during the puppy's/dog's first two years of life while in possession of buyer. The puppy/dog will also be placed on heartworm preventative for a minimum of two years. Failure to follow any of the requirements in this contract causes any health warranties stated in this contract to become null and void. Buyer must have proof from a veterinarian that the puppy/dog was up-to-date on all vaccinations, dewormings, and heartworm prevention at all times.

#### **Spaying – Neutering**

We recommend spaying or neutering any dog to avoid unwanted pregnancies and overpopulation. NOTE all of our dogs are sold as pets.

#### **Feeding**

Your dog had been fed Eukanuba Small Breed Puppy Food. If you decide to change the food, do so very gradually or it may cause issues that will require medical attention.

This writing constitutes the full agreement of the parties.
